2. The Conveyance Allowance mentioned above shall also be admissible to the corresponding posts of the Local Fund Accounts wing of the Department of Finance.
2. Those employees who have been allotted Government vehicle shall not be entitled to Conveyance Allowance.
3. These orders shall come into force with effect from the 1<sup>st</sup> December, 2011.
