2. The grant of above noted scale to the Craft Instructor is subject to the condition that the Departmental Service Rules shall be amended and the prescribed minimum qualifications for this post shall be a polytechnic diploma or equivalent.

The pay in the above mentioned revised scales of pay effective from the 1st December, 2011 shall be fixed prospectively and there shall be no element, whatsoever, of retrospectivity in this regard and there will be no question of payment of arrears or of fixation of pay on notional basis from any previous date.

4. The employees working on the above noted posts shall not be entitled to any Special Grade Pay in terms of Government circular letter No.5/10/09-5FPI/807, dated 14th November, 2011.

5. The necessary amendments in the rules will be made in due course.
