Subject: - Implementation of the recommendations of the Fifth Punjab Pay Commission -
(i) Grant of Scooter/Motor-Cycle Allowance to Assistant Sub-Inspectors,
Sub-Inspectors and Inspectors of Police
(ii) Grant of Cycle Allowance to the Head Constables and Constables.

Sir,

I am directed to invite a reference to the subject cited above and to say that after careful consideration of the recommendations of the Fifth Punjab Pay Commission, the Governor of Punjab is pleased to decide that:-

- (a) the existing Scooter /Motor-Cycle Allowance admissible to the Assistant Sub-Inspectors, Sub-Inspectors and Inspectors of Police shall be revised from Rs. 90 (Rupees ninety only) per mensem to Rs.180 (Rupees one hundred eighty only) per mensem This decision will also be applicable to the similar category of employees posted in the C.I.D. Punjab.
- (b) the existing Cycle Allowance admissible to the Head Constables and Constables shall be revised from Rs. 20 (Rupees twenty only) per mensem to Rs. 40 (Rupees forty only) per mensem.
2. The existing terms and conditions for grant of above mentioned allowances shall continue to be in force.
3. These orders shall come into force with effect from the 1st October, 2010.
4. The Punjabi version of these orders will follow in due course.
