- (a) the existing Scooter /Motor-Cycle Allowance admissible to the Assistant Sub-Inspectors, Sub-Inspectors and Inspectors of Police shall be revised from Rs. 90 (Rupces nincty only) per mensum to Rs.180 (Rupees one hundred eighty only) per mensem This decision will also be applicable to the similar category of employees posted in the C.I.D. Punjab.
- (b) the existing Cycle Allowance admissible to the Head Constables and Constables shall be revised from Rs. 20 (Rupees twenty only) per mensem to Rs. 40 (Rupces forty only) per mensem.

2. The existing terms and conditions for grant of above mentioned allowances shall continue to be in force.

These orders shall come into force with effect from the 1<sup>st</sup> October, 2010.
