Implementation of the recommendations of the Fifth Punjab Pay Commission – Admissibility of Family Planning Allowance as an incentive for adoption of small family norms.

Sir,

I am directed to refer to the subject cited above and to say that after careful consideration of the recommendations of the Fifth Punjab Pay Commission the Governor of Punjab is pleased to decide that with effect from 1<sup>st</sup> May, 2010, Family Planning Allowance equal to the amount of one increment on the revised basic pay under the Punjab Civil Services (Revised Pay) Rules, 2009 subject to a minimum of Rs. 210/- shall be admissible to Group C and D employees of Punjab Government as an incentive for adoption of small family norm.

- 2. It has been further decided that with effect from 1<sup>st</sup> May, 2010 Family Planning Allowance equal to the amount of two increments on the revised basic pay shall be admissible to Group C and D employees of Punjab Government as an incentive for adoption of small family norm if they restrict the number of children to two girls only.
- 3. It has also been decided that the amount of Family Planning Allowance already drawn by any category of employees before 1<sup>st</sup> May, 2010 shall continue to be drawn subject to a minimum of Rs. 210/- per month with effect from 1<sup>st</sup> May, 2010.
- 4. It is clarified that the Punjab Government employees who adopted small family norms from 1.1.2006 to 30.4.2010 will also continue to draw Family Planning Allowance equal to the amount of one increment on the pre-revised basic pay subject to a minimum of Rs. 210/- per month with effect from 1<sup>st</sup> May, 2010.
- 5. All other terms and conditions governing the grant of Family Planning Allowance as already notified by the Government of Punjab, Department of Health & Family Welfare shall continue to be in force.
